SUPER 8 BY WYNDHAM









The <u>Super 8 by Wyndham</u> brings a new look to the Highway 16A corridor in Spruce Grove. Located at 240 St. Matthews Avenue, this property is the former Grove Motor Inn, which was a fixture on Highway 16A since 1976.

The property changed ownership in 2019, which put in motion a multi-million dollar renovation and rebranding to Super 8 by Wyndham. The new owner, Justin Burwash, also operates a Super 8 in Cochrane.

Most of the renovations have been completed in the main building, which consists of 46 rooms, swimming pool and hot-tub, lobby, restaurant, pub with a VLT gaming room and off-track horse racing, and the exterior facade. The annex has another 47 rooms, which are currently in the process of being renovated.

The renovations for this year also include a banquet room and repaving their parking lot this summer. Super 8 employs approximately 30 staff, most of which are full time.

"Many renovations have taken place in the past year. The pool is up and running and the lobby is complete, along with the whole front desk, floors, and ceilings. Super 8 also has a working fireplace and a bar, which enhances the overall experience for guests." - Charlene Mytrunec, General Manager

Super 8 values building relationships with local companies. Broadway & Grand has been brought in to operate the restaurant, which offers authentic, local cuisine and hand-crafted meals to their guests.

Management and staff look forward to welcoming guests back to this location, including a number of hockey and school volleyball teams this fall.

COVID-19 Resources



Our business community has been significantly impacted by the most recent COVID-19 measures implemented by the Alberta Government. The *City of Spruce Grove* maintains an up-to-date database of <u>relevant support programs</u> as well as <u>COVID-19</u> FAQs for businesses.

□ COVID-19 SUPPORT PROGRAMS □

Federal Budget extends several key COVID-19 support programs to Fall 2021.

NEW: Alberta Jobs
Now Program



Private and non-profit businesses can apply for funding to offset the cost of hiring and training unemployed or underemployed Albertans into new or vacant full-time jobs. Applications for the first intake will close on August 31, 2021.

NEW: Alberta's Innovation Employment Grant



Provides up to a 20% tax credit towards R&D. The grant will be phased out for firms with \$10M to \$50M in taxable capital and will provide benefits up to \$4M in annual R&D spending. Delivered through the corporate tax system.

EXPANDED: Employment Insurance
Program (EI)

NEW: Canada Emergency Rent Subsidy (CERS)



Commercial rent and mortgage support to organizations. Lockdown Support provides an additional 25% of support or 90% to businesses greatly impacted. Applications will remain open until September 25, 2021.

EXPANDED: Highly Affected Sectors

Credit Availability Program



The HASCAP program provides businesses heavily impacted by the COVID-19 pandemic to access low-interest loans of \$25,000 to \$1,000,000 to cover cash flow needs. Applications will remain open until December 30, 2021.

EXPANDED: Canada Recovery
Benefit (CRB)





CERB has transitioned to EI. The number of weeks of EI benefits is proposed to be increased to a maximum of 50 weeks for claims made between September 27, 2020 and September 25, 2021.

Those not eligible for EI can apply through CRB. This allows recipients to apply for a total of 21 periods (42 weeks) between September 27, 2020 and September 25, 2021.

EXPANDED: Canada-Alberta Job Grant

EXPANDED: Canada's Work Sharing Program





Funding to help employees and unemployed Albertans access training opportunities. Employers to contribute 1/3 of costs and government contributes 2/3 to a maximum of \$10K/year/trainee.

Extended from 38 to 76 weeks, eligible employers may immediately enter into a new agreement. Eligibility has expanded to include businesses who have been in business for 1 year and essential staff.

EXPANDED: Canada Emergency Business Account (CEBA)

Canada Emergency Business Account (CEBA)





An employer who has seen a drop in revenue may be eligible for a subsidy to cover part of employee wages. Changes allow a top-up of 35% and a subsidy amount of \$595 for employees on leave with pay. Deadline extended to September 25, 2021.

In addition to the \$40,000 interest-free loan, eligible businesses impacted by COVID-19 can access an additional interest-free loan of up to \$20,000. Applicants have until **June 30, 2021** to apply for the \$60,000 loan or the \$20,000 expansion.

Small and Medium Enterprise Relaunch Grant (SMERG)



Businesses operating since February 29, 2020 and those that began between March 1, 2020 - March 31, 2021 can apply for up to \$10,000. Applications remain open until **June 30, 2021**.

Regional Relief and Recovery Fund (RRRF)



The RRRF now offers up to an additional \$20,000 for eligible small and medium-sized enterprises (SMEs) needing continued financial support. Deadline extended to **June 30, 2021**.
