WAUKESHA PEARCE INDUSTRIES CANADA (WPI)



<u>Waukesha Pearce Industries (WPI)</u>, a pioneer in engine technology with nearly 100 years in business, has landed its Canadian head office in Spruce Grove. With 17 US locations and 3 locations in Canada—Nisku, Grande Prairie and Fort St. John—the Texas-born company is extending its reach across North America.

Located at 441 South Avenue, WPI is touted as Canada's one-stop-shop for everything natural gas engine-related. They offer certified remanufacturing of natural gas engines and compressors, the world's largest inventory of Waukesha and Ariel engine parts, and a vast inventory of remanufactured engines for all major equipment lines.

WPI's roots in Spruce Grove begin with Toni Moretto, who moved his company, Tritech Compression Inc., to Spruce Grove in 2005, where he invested in Canada's first natural gas engine test cell. In 2009, the business was purchased by Hoerbiger Holding AG, a global player in compression, automation, and drive technology. When Hoerbiger shifted its operations in 2020, WPI took the opportunity to partner with Toni and expand WPI Canada.

Now Director of Operations for WPI Canada, Toni oversees work at the 40,000 square-foot facility situated on a 6 acre site. The facility features Canada's only natural gas dynamometer, with capabilities of up to 4,000 horsepower and 4 to 24-hour diagnostic test run options.

WPI has approximately 60 employees in Canada, with 20 in Spruce Grove – a number that is expected to double in the near future. Locating in Spruce Grove has been instrumental in the evolution of the business.

#### **BEND THE CURVE**

The *Government of Alberta* has released a new 4-step plan to ease public health restrictions based on hospitalization benchmarks.

Effective March 1, additional health measures were eased for indoor fitness facilities to include low-intensity activities and for libraries to reopen, with restrictions.

#### $\Box$ THE CITY OF SPRUCE GROVE'S RESPONSE TO COVID-19 $\Box$

Our business community has been significantly impacted by the most recent measures implemented by the Province of Alberta. The *City of Spruce Grove* has compiled relevant information as well as COVID-19 FAQs for businesses.

# **UPCOMING: Enhanced COVID-19 Business Benefit**



Up to \$30,000 in support for businesses affected by the pandemic. Additional funds of \$10,000 can be used to offset costs such as PPE, bills, or hiring staff. This program will launch in April 2021.

### NEW: Canada Emergency Rent Subsidy (CERS)



Provides commercial rent and mortgage support to organizations affected by the pandemic. Lockdown Support allows organizations affected by the public health order to receive an additional 25% of support. Renters and property owners can receive payment without the participation of landlords. Applications for claim period 5 (January 17 to February 13, 2021) are now open.

EXPANDED: Employment Insurance
Program (EI)

### NEW: Highly Affected Sectors Credit Availability Program (HASCAP)



This program will provide businesses heavily impacted by COVID-19 with the ability to access guaranteed, low-interest loans of \$25,000 to \$1 million to cover operational cash flow needs.

### NEW: Alberta's Innovation Employment Grant



To promote investment and diversification, Alberta launched this grant where companies can receive up to a 20% tax credit towards research and development expenditures. The grant will be phased out for firms with \$10M-\$50M in taxable capital and will provide benefits up to \$4M in annual R&D spending. This grant is delivered through the corporate tax system.

**EXPANDED: Canada Recovery Benefit** 



The CERB program has transitioned to EI to provide support to those who qualify for EI benefits, but are unable to work. The number of weeks of regular EI benefits is proposed to be increased to a maximum of 50 weeks for claims made between September 27, 2020 and September 25, 2021.

# EXPANDED: Canada Emergency Business Account (CEBA)



In addition to the \$40,000 interest-free loan, businesses and non-profits impacted by COVID-19 will now be able to access an additional interest-free loan of up to \$20,000. Applicants have until March 31, 2021 to apply for the \$60,000 loan or the \$20,000 expansion.

# EXPANDED: Canada's Work Sharing Program



Extended from 38 to 76 weeks, eligible employers may immediately enter into a



Individuals not eligible for EI can apply for income support through the CRB program. A proposed extension to the time eligibility period limits will allow eligible recipients to apply for a total of 19 periods (38 weeks) between September 27, 2020 and September 25, 2021.

# EXPANDED: Canada Emergency Wage Subsidy (CEWS)



An employer who has seen a drop in revenue may be eligible for a subsidy to cover part of employee wages. Changes allow a maximum top-up of 35% and a maximum subsidy amount of \$595 for employees on leave with pay. The base revenue rate of 40% will remain in place.

# EXPANDED: Regional Relief and Recovery Fund (RRRF)



The Regional Relief and Recovery Fund (RRRF) has expanded and now offers up

new agreement. Eligibility has expanded to include businesses who have been in business for 1 year and essential staff.

EXPANDED: Alberta Small and Medium Enterprise Relaunch Grant



This program provides up to a maximum of \$20,000 for businesses, cooperatives, and non-profit organizations that experienced a revenue reduction of at least 30%. Businesses that started operations between March 1 and October 31, 2020 can now apply. Applications are open until March 31, 2021.

to an additional \$20,000 for eligible small and medium sized businesses needing continued financial support.

EXPANDED: Canada-Alberta Job Grant



As part of Alberta's recovery efforts, employers can apply for funding to help employees and unemployed Albertans access training opportunities. Employers are required to contribute 1/3 of the training costs and government contributes 2/3 to a maximum of \$10,000 per trainee per year.

Edmonton Trade Accelerator Program



This program helps businesses reach their global potential by providing access to industry experts to develop and execute a personalized market-entry export plan. Companies from Spruce Grove are encouraged to apply.


**Energy Savings for Business Program**
